MEETING OF THE BOARD OF HEALTH WAS HELD ON FRIDAY NIGHT, APRIL 19, 1963, AT 7:30 P. M.

MINUTES OF THE PREVIOUS MEETING READ AND APPROVED AS READ:

- DR. ADAIR READ A LETTER FROM THE SWITOW AMUSEMENT COMPANY REGARDING THE LE ROSE THEATRE'S UNSANITARY CONDITION. ALSO READ HIS LETTER TO THE SWITOW AMUSEMENT COMPANY: POINTING OUT THE UNSANITARY CONDITIONS AND THE IMPROVEMENTS THAT WOULD HAVE TO BE MADE, IN ORDER THAT THEY COULD CONTINUE TO OPERATE THE THEATRE.
- 2. REGARDING THE TATTOO ARTIST, ACE DIAMOND AND EXTENSIVE DISCUSSION THAT HAD BEEN CARRIED ON; DR. ADAIR TOLD THE BOARD THAT HE HAD APPEALED TO DR. WALTER BENEVILLE, STATE REPRESENTATIVE, WHO IN TURN HAD INTRODUCED A BILL FOR THE ELIMINATION OF " TATTOOING IN INDIANA," UNLESS FOR MEDICAL PURPOSES.

 THIS LAW WAS PASSED BY THE LEGISLATURE IN ITS MARCH SESSION,
- 3. DR. ADAIR DISCUSSED WITH THE BOARD HIS CONCERN REGARDING GROCERIES AND STANDS WHO HAD BASKETS OF FRUITS AND VEGETABLES DISPLAYED ON THE SIDEWALK, WHICH HE FELT WAS UNSANITARY, DUE TO THE FACT THAT ANIMALS COULD HAVE ACCESS TO IT AND THAT PERSONS PASSING BY COULD EXPECTORATE ON SAME. HE STATED THAT HE WAS IN THE PROCESS OF HAV ING THE CITY PASS AN ORDINANCE TO DO AWAY WITH THESE SIDEWALK DISPLAYS.
- 4. RELATIVE TO THE V K CONSTRUCTION COMPANY, DR. ADAIR READ A LETTER FROM THE STREAM POLLUTION DIVISION, INDIANA STATE BOARD OF HEALTH, ALSO OUR REPLY TO THIS LETTER ADDRESSED TO MR. POOLE, RE: LINCOLNHEICHTS SUBDIVISION.
- 5. THE OAK PARK SEWER SYSTEM WAS ALSO DISCUSSED AND DR. ADAIR FELT THAT THEY WOULD WOULD BE COMPLETED SOMETIME BETWEEN JUNE AND JULY OF THIS YEAR.
- 6. THE MATTER OF A DOG CATCHER WAS DISCUSSED AND LETTER READ FROM THE INDIANA STATE BOARD OF HEALTH. ALSO LETTER FROM A CLARK COUNTIAN, MR. PENNINGTON ALONG WITH DR. ADAIR'S LETTER, WITH SUGGESTIONS TO THE CLARK COUNTY COUNCIL, REGARDING

THE NEED OF A DOG CATCHER. HE ASKED THE BOARD IF HE HAD DONE EVERYTHING
IN HIS POWER TO CET THIS ESTABLISHED, OR DID THE BOARD FEEL THAT ANYTHING
MCRE COULD HAVE BEEN DONE. IT WAS THE UNANAMOUS FEELING OF THE BOARD
THAT DR. ADAIR SHOULD CONTACT THE COMMISSIONERS AT LEAST ONCE MORE, REGARDING
THIS MATTER AND ALSO THAT DR. ADAIR TRY TO FIND OUT WHAT HAD HAPPENED TO
THE FUND FOR THIS PURPOSE; AND THAT HE WRITE AN INDIVIDUAL LETTER TO EACH
COMMISSIONER RELATIVE TO THIS MATTER.

- 7. DR. ADAIR READ HIS LETTER TO MR. LOGAN DELLINGER, PLANNING AND ZONING COMMISSION RELATIVE TO THE VK CONSTRUCTION COMPANY, REQUESTING THE PLANNING AND ZONING TO WITHHOLD FURTHER PERMITS UNTIL SATISFACTORY SEWAGE FACILITIES WERE ESTABLISHED TO COMPLY WITH HEALTH DEPARTMENT REGULATIONS.
- 8. THE BUDGET FOR 1964 WAS DISCUSSED AT LENGTH AND DR. ADATR POINTED
 OUT THE DIFFERENT CATEGORIES AND VARIOUS SALARIES, WHICH HE HAD REQUESTED;
 WHICH WERE DENIED.

IT WAS MOVED BY DR. BOWER AND UNANMOUSLY AGREED THAT DR. ADAIR OBTAIN
THE SERVICES OF MR. ELLIS DETBEL, TO EXPLAIN THE STATE LAW RELATIVE TO THIS
SITUATION TO THE CLARK COUNTY COUNCIL, REGARDING THE SALARIES IN THE CLARK
COUNTY HEALTH DEPARTMENT AND IN CASE THE SALARIES WERE REFUSED, DR. ADAIR
WAS INSTRUCTED TO AUTHORIZE MR. DETBEL TO FILE SUIT AGAINST THE COUNTY
COUNCIL.

MR. WILLIAM BRUMMETT MINUTES OF THE PREVIOUS MEETING READ AND APPROVED.

IN DISCUSSING THE BUDGET FOR 1964 DR. ADAIR ENFORMED THE BOARD OF THE SALARY INCREASES AND ADDITIONAL APPROPRIATIONS NEEDED TO COMPLETE THE YEAR OF 1963: SAID THAT COUNTY COUNCIL HAD APPROVED THE FOLLOWING: MARIE BELVER RN.\$400.00 ARTHUR REICHLE \$300 00 EFFIE MOSS RN. \$400100

OTHER CATEGORIES MILEAGE GRANTED \$300:00 \$75:00 TELEPHONE DUES AND SUBSCRIPTIONS \$10:00 -

DR. ADAIR READ LETTER TO THE BOARD FROM THE ASST. ATTY. GENERAL OF STATE OF INDIANA, ADDRESSED TO ACE DIAMOND, TATTO ARTIST, WHICH INFORMED ACE OF THE LAW PASSED RECENTLY, MAKING IT MANDATORY THAT HE CEASE THE BUSINESS OF TATTOOING IN THE STATE OF INDIANA.

MR. JOE COOMBS. WITH THE AID OF A MAP. ASSISTED DR. ADAIR IN EXPLAINING THE SEWAGE PROBLEM IN THE VICTORY COURT, TAYLOR DRIVE AREA. THE BOARD UNANMOUSLY FELT THAT IT WOULD BE BETTER TO LET THESE PEOPLE FORM THEIR OWN CORPORATION, RATHER THAN FORCE THE RESIDENTS TO TAP INTO MR. JACK JACOBS SEWER. WHICH WOULD BE MORE COSTLY THAN THEIR OWN SYSTEM.

RELATIVE TO THE LINCOLN HEIGHTS SEWAGE PROBLEM. MR. COOMBS ALSO TOLD THE BOARD OF HIS MEETING WITH MRS. ALAN WILLNER AND COMMITTEE FROM CLARKSVILLE, ALONG WITH THE TOWN BOARD. HE STATED THAT IT WAS THE DESIRE OF THIS GROUP TO TRY TO HAVE LINCOLN HEIGHTS ANNEXED TO CLARKSVILLE. DR. ADAIR SUGGESTED THAT HE MIGHT WRITE A LETTER TO TRY AND GET A CONSERVANCY FOR THESE PEOPLE, SIMILAR TO THE OAK PARK ONE. THE BOARD UNSNAMOUSLY APPROVED OF THIS ACTION.

DR. ADAIR TOLD THE BOARD THAT ONLY ABOUT ONE HALF OF THE PERSONS RESIDING IN OAK PARK HAD HOOKED UP TO THE SEWER RECENTLY INSTALLED AND THAT HE FELT THAT ALL PERSONS IN OAK PARK SHOULD BE HOOKED TO THIS SEWER. IT WAS THE UNANAMOUS OPINION OF THE BOARD THAT THIS BE DONE AND SUGGESTED THAT IT BE MADE PUBLIC BY INSERTING AN ARTICLE IN THE LOCAL NEWSPAPER. GIVING THESE PERSONS IN OAK PARK A TIME LIMIT OF 6 MONTHS FROM SEPT.20 1963 TO CONSUMATE THIS HOOK-UP. GROCERY AND RESTAURANT SAMPLE ORDINANCES WERENE DISCUSSED AND COPIES GIVEN TO EACH BOARD MEMBER . ALSO FELT THAT IF THESE PLACES WERE LICENSED IT WOULD INSURE A MORE SANITARY CONDITION IN CLARK COUNTY.

DUMPS AND COUNTY OPERATED INCINERATOR WERE DISCUSSED. THE BOARD UNANAMOUSLY AGREED THAT THEY GO ON RECORD AS RECOMMENDING THAT THE COUNTY AUTHORITIES INVESTIAGE THE FEASIBILITY OF THE FUTURE CONSTRUCTION OF COUNTY OPERATED INCINERATOR.
