The items were removed from store shelves after the manufacturer, Stonewall Kitchen, informed Giant that some aspects of the manufacturing process did not meet their food safety standards and the products may have the potential to be contaminated with *Clostridium botulinum*.

The items were removed from store shelves after the manufacturer, Stonewall Kitchen, informed Giant that some aspects of the manufacturing process did not meet their food safety standards and the products may have the potential to be contaminated with *Clostridium botulinum*, a bacterium which can cause life-threatening illness or death. Consumers are warned not to use the product even if it does not look or smell spoiled. Simply Enjoy products are part of Giant's corporate brand line.

Giant Food has received no reports of illnesses associated with consumption of this product.
